Re: PMFBY Rabi (Special Season) and Rabi (Other Crops) Enrolment through CSC.

We wish to inform that Notification for implementation of PMFBY during Rabi (Special Season) and Rabi (Other Crops) has been issued by Government of Tamil Nadu and Enrolment of farmers is being done through different stakeholders like Banks and CSC. In past seasons, it was noticed that some farmers are misusing the scheme provisions and doing enrolment more than once and multiple enrolment for the same piece of land by following ways.

1. Insuring same land at both bank and CSC with same Adangal.
2. When we insist original Adangal, getting multiple Adangal for same land for enrolment.
3. As original Adangal is returned back to the farmers soon after enrolment, the farmers insure again same Adangal with other CSCs.
4. Adangal for same piece of Land is being collected by different farmers as Tenent cultivators, Eventhough Tenancy is not legalised in our State and insurance by more than one person.

Due to these types of malpractices the purpose of the scheme is defeated. The CSC enrolment issue has been discussed in different meetings including SLCCCI. In one such meeting it was suggested to affix a seal with date of the CSC centre on the original Adangal during enrolment. The Sealed Adangal shall be scanned and uploaded during enrolment. By this way we shall ensure that the same sealed Adangal cannot be used in other centres.

Under these circumstances, we now request you to issue necessary directions to all the CSCs to strictly adhere to the following instructions while uploading the Adangal document in NCIP portal. In connection with farmer enrolment;

1. Ensure that the farmer is producing **ORIGINAL ADANGAL ONLY** And not photocopy to the CSC VLE.
2. After confirming the veracity of the original Adangal document, the CSC VLE shall without fail affix a **Rubber stamp on this Original Adangal invariably before scanning and uploading** the same in GOI portal.
3. The Rubber stamp affixed shall be to this effect "Certified that this Adangal is used by the farmer for enrolment under PMFBY through our CSC M/S _____".
4. Please ensure that Rubber stamping done to the above effect is clearly visible in the scanned and uploaded image of the adangal document in GOI Portal.

Kindly do the needful at the earliest for the benefit of farming community.
